**CONDITIONS & ACKNOWLEDGEMENT**  
**FOR USE OF THE GOLDEN AGE SOCIETY**

*The following conditions apply:*

1. **Conditions of Premises:** The Golden Age Society shall keep the premises in a good state of repair and shall comply with any statutory enactment or law respecting standards of health and safety.  
The renter of the facility will ensure it is always treated in a respectful manner.
2. **Good Behavior:** The renter shall conduct him/herself in such a manner as to not bring discredit to the Golden Age Society or themselves. The renter is also responsible for the conduct of all attendees at the event.
3. **Obligation of the renter:** The renter shall be responsible for the removal of all decorations or other items brought to the Golden Age Society for the purpose of the event. The Renter is required to ensure the premises are left in a clean condition, with tables and chair place back where they were brought from. Ensure all windows a locked, blinds down, and back door is not used and kept locked, unless for an emergency.  
The renter is required to provide a Damage/Key deposit of \$50.00 which will be returned when the key is brought back. (Within two days after the event).
4. **Entry of Premises:** Golden Age Office Manager or other designated person(s) may require access to the office to conduct Golden Age Society business during rental time.

5. **Liquor on Premises:** Wine or Beer is permit if Liquor license is in place, and a copy of the license is given to the Manager or Executive beforehand. No liquor is permitted to be given to minors.

6. **Security of Premises:** a) **During regular business hours:** Golden Age Society personnel will ensure that the doors are securely locked, and alarm is set when they leave.

(con't)** b) **Outside regular business hours:** Arrangements will be made to ensure that the Renter is provided access to the facility during the time required. If required, the Renters will be provided with a key and code to access the Golden Age Society for the duration of their function. Renters will be required to ensure the facility if always monitored/secured and limited access is granted during the rental time. No person, unless authorized by the Renter or Executive will be granted access to the rented area during the rental time.

**Yukon Liquor Corporation – Liquor Permit conditions:**

1. At no occasions no person may give, sell or otherwise supply liquor to a person under the age of 19 and no person under the age of 19 may have, consume, purchase or attempt to purchase liquor.
2. All liquor sold or served at a special occasion shall be consumed in the room or the place mentioned in the permit before the permit expires.
3. Person in charge, staff and volunteers must not consume liquor while on duty.
4. Food shall be made available for each person attending a reception or special occasion event.
5. The holder of a permit shall be responsible for the lawful use of the permit and premises.
6. No liquor may be served at a special occasion except during the hours stated in the permit.
7. Permit holders shall not keep for sale or consumption liquor other than purchase from the Corporation Liquor store or warehouse. The Golden Age Society shall keep and maintain a record of all purchases.
8. The permit shall be displayed in a prominent position as the area where liquor is to be served.

**No person** may give, sell or other wise supply liquor to a person **under the age of 19 years** and **no person under the age of 19 years** may have, consume, purchase, or attempt to purchase liquor, beer or wine. **REGULATION 37 SECTION 13.**
